1 As requested by the Court at the settlement hearing on December 17, 2010, plaintiffs
2 provide this notice to the Court that the Final Judgment and Order of Dismissal with
3 Prejudice may be entered, now that the waiting period pursuant to 28 U.S.C. § 1715(d) has
4 passed.

5 Pursuant to 28 U.S.C. § 1715(d), such an order may not be issued earlier than 90
6 days after the appropriate federal and state officials are served with notice of the proposed
7 settlement, and defendants served that notice on November 12, 2010. Thus, the parties
8 requested that entry of the order giving final approval to the proposed settlement be delayed
9 until February 10, 2011, which is today.
