SUMMARY NOTICE OF CLASS SETTLEMENT

Lamps Plus Credit Transaction Cases,
Superior Court of California, County of Los Angeles,
Judicial Council Coordination Proceeding No. 4532

This is a Summary Notice of a class action settlement that has been preliminarily approved by the Court referenced above and may affect your rights. The settlement resolves claims under the Song-Beverly Credit Card Act of 1971 (California Civil Code Section 1747 *et seq.*), which are based on allegations that Lamps Plus, Inc. ("Lamps Plus") requested or required certain customers to provide their address and/or telephone number during credit card transactions. The settlement does not apply to or involve customers who were requested for information in connection with shipping, delivery, servicing, or installation of purchased merchandise, or in connection with special orders. If this Notice applies to you, you should carefully read the Full Settlement Notice, which can be found online at <http://www.Gilardi.com/LampsPlus> or by writing to Finch/Taylor v. Lamps Plus, c/o Gilardi & Co., P.O. Box 8060, San Rafael, CA 94912-8060. The Full Settlement Notice contains a complete description of the class and the case.

If this notice applies to you, you may be entitled to receive a \$20 voucher that can be used toward the purchase of any product at any Lamps Plus, Inc. store in California. To be eligible, you must submit a valid Claim Form, which can be obtained online at <http://www.Gilardi.com/LampsPlus> or by writing to the address above. The Claim Form and ALL documentation must be submitted as instructed in the Claim Form by September 22, 2009. See the Full Settlement Notice for details. The settlement includes a release by all class members. If the settlement is finally approved, this release will bind all class members who do not opt out and bar any claims subject thereto. Other terms of the settlement, including payment of attorney fees, are in the Full Settlement Notice. You may request to be excluded from the settlement by sending a letter to Finch/Taylor v. Lamps Plus, c/o Gilardi & Co., P.O. Box 8060, San Rafael, CA 94912-8060, postmarked by no later than September 7, 2009. The letter must be signed, must include your full name and address, and must state: "I request to be excluded from the class settlement in the Lamps Plus Credit Transaction Cases." See the Full Settlement Notice for more details.

The Court has scheduled a hearing on October 1, 2009, at 4:00 p.m. in Department 309 of the Court listed above, located at 600 South Commonwealth Avenue, Los Angeles, California 90005, to consider whether to grant final approval of the settlement. In order to appear and object to the settlement, you must object in writing and file it with the Court no later than September 7, 2009, and mail it to the persons listed in the Full Settlement Notice. You may enter an appearance through your own counsel if you wish. If you decide to object to the settlement you may still participate in the settlement and receive benefits under the settlement.
